HIPAA "...will also require HIPAA covered entities to continue to use ICD-9-CM through September 30, 2015."

ICD-10 Roadmap

- ICD-10 to SNOMED smarts in place by April 2015 (v6.28)
- MassHealth and CMS looking for end-to-end testers

EHR Roadmap

- V6.24 Orders may now have diagnoses attached
- Spellcheck coming in v6.25
 - Tentative release 11/2/14
 - v6.26 tentative release 1/25/15

- ICD-10-CM 2015 Addendum:

“There were no changes to the 2014 ICD-10-CM, therefore there are no 2015 ICD-10-CM Addenda.”

Documentation

- Lion's share of improvement/adaptation lies here
- Do documentation assessments NOW
- The sooner you *and your staff* understand how *your* documentation habits align with documentation requirements, the sooner you can find and implement strategies for improvement

“We have heard from many plans that have said the use of unspecified codes will not guarantee payment, the continued use of unspecified codes will reduce payments and the use of unspecified codes will pend your claim until education is provided.”

Episode of Care – 7th Character

- Initial “A”
- Subsequent “D”
- Sequela(e) “S”
- Placeholder X

ICD-10 Example

- Shaken Infant Syndrome
 - SNOMED in the visit record
“Shaken *baby* syndrome”
 - T74.4 is merely the root code

Initial Encounter

- While patient is receiving active treatment
 - Inpatient, trauma care
 - T74.4XXA

Subsequent Encounter

- After active treatment; receiving routine care during healing/recovery
 - T74.4XXD

Sequela

- Complications or conditions that arise as a direct result of a condition
 - Resulting intellectual or physical disabilities
 - F71 – *Moderate* Intellectual Disability
 - SNOMED “Intellectual functioning disability”
 - T74.4XXS

Vaccines

- Z23 Encounter for Immunization
 - Code first any routine childhood examination
 - CPTs will identify the immunizations given

Immunization *Not* Carried Out

- Z28.01 acute illness
- Z28.02 chronic illness or condition
- Z28.03 immune compromised state
- Z28.04 allergy to vaccine or component
- Z28.09 other contraindication
- Z28.1 patient decision for reasons of
 - belief or group pressure
 - religious belief

Immunization *Not* Carried Out (cont'd)

- Z28.2 other/unspecified reason
- Z28.20 patient decision for unspecified reason
- Z28.21 patient refusal
- Z28.29 patient decision for other reason
- Z28.81 due to patient having had disease
- Z28.82 caregiver/guardian/parental refusal

Underimmunized Status

- Z28.3 Underimmunization status
 - Delinquent
 - Lapsed schedule

Excludes1

- Immunization not carried out because of
 - caregiver refusal because of religious belief (Z28.1)
