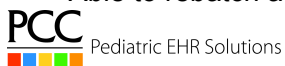

Control Your Future™

PCC v7.3 Highlights

- Link Multiple ICD Codes to any SNOMED
- Track Gestational Age
- Fenton preterm growth charts
- Make Partner available through PCC EHR
- Interactively work with list of accounts on prepared bills list
- Able to rebatch a claim as a claim



Control Your Future™

Telemedicine

- More CPTs requested in Dec (mostly rehab)
- State dependent
 - Rules where *patient* is; not clinician
- Originating site = patient's location

Your Coding Q's

- ICD-10 Fallout
 - Grace periods?

Your Coding Q's (cont'd)

Diagnoses for screenings

- Well
 - Age-dependent
- Other
 - Z41.8 Encounter for other procedures for purposes other than remedying health state

Screenings (cont'd)

- Z01.10 Encounter for exam ears & hearing *without* abnormal findings
 - Encounter for exam ears & hearing NOS
- Z01.11 ... *with* abnormal findings
 - Z01.110 Encounter for hearing examination following failed hearing screening
 - Z01.118 Encounter for examination of ears and hearing with other abnormal findings
 - Use additional code to identify abnormal findings

Screenings (cont'd)

- Z01.0 Encounter for examination of eyes and vision
 - Excludes1: examination for driving license (Z02.4)
- Z01.00 ... exam eyes & vision *without* abnormal findings
 - Encounter for examination of eyes and vision NOS
- Z01.01 ... exam eyes & vision *with* abnormal findings
 - Use additional code to identify abnormal findings

Administrative Exams

- CPT
 - E&M
 - Consult
 - 99499 Unlisted E&M service
- ICD
 - Z02.89 Encounter for other administrative examinations

Your Coding Q's (cont'd)

Modifier 33 Preventive Services

“When the primary purpose of the service is the delivery of an evidence-based service in accordance with a U.S. Preventive Services Task Force A or B rating in effect and other preventive services identified in preventive services mandates (legislative or regulatory), the service may be identified by adding 33 to the procedure.”

Documentation Q

- -25 Simultaneous Sick and Well
 - Separate notes/no double dipping
 - Two of three rule
