Health Risk Assessments

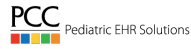
- 99420 Expired 12/31/16
- New codes eff 1/1/17
 - 96160 Administration of **patient-focused** health risk assessment instrument (eg, health hazard appraisal) with scoring and documentation, per standardized instrument
 - 96161 Administration of **caregiver-focused** health risk assessment instrument (eg, depression inventory) for the benefit of the patient, with scoring and documentation, per standardized instrument

Health Risk Assessments

- Some carriers are rejecting 96160, 96161
- AAP
 - Accepts CMS's determination that they are add-on codes.
 - Recommends NOT billing them with Well care.



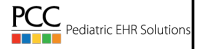
Health Risk Assessments

- I say bill 96160, 96161 as you did 99420 because:
 - These codes do not have the + sign indicative if an add-on code in CPT 2017.
 - "Although a new code has been assigned to this service, there is no change in the intent for use of this code (ie, the change for this code is editorial in nature)." - CPT® 2017 Changes: An Insider's View



Coding Question

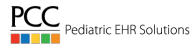
"I noticed that our procedures only have orders for "wart removal 1-14 lesions". What about molluscum destruction/removal? Do I need that in procedures as well, as they are non-wart lesions, requiring treatment? We use cantharone as treatment for both warts and molluscum."



Coding Answer

CPT defines lesions thusly:

“Lesions include condylomata, papillomata, molluscum contagiosum, herpetic lesions, warts, (e.g., common plantar, flat) milia or other benign, premalignant (actinic keratoses) or malignant lesions.”



Coding Answer

So long as the lesions are *benign*, these codes apply:

- 17110 – Destruction (e.g., laser surgery, electrosurgery, cryosurgery, chemosurgery, surgical curettment), of benign lesions other than skin tags or cutaneous vascular lesions; up to 14 lesions
- 17111 – 15 or more lesions

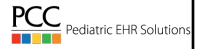

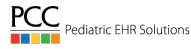

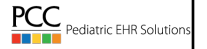

AAP Advocacy

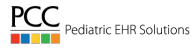

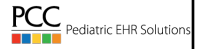

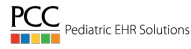
Roadmap – Version 7.6

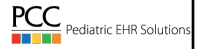
Deployment for PCC 7.6 will happen 1 week later than planned:
