2017 CPT Changes

Effective 1/1/17

CMS changes:

- Complex Chronic Care services become payable by CMS
- Separate payment for non face-to-face prolonged care 99487 & 99489





Flu Vaccine

- - o 90674 Flu quad from cell cultures, subunit, preservative- & antibiotic free, 0.5 ml, IM
- Per AAP: "Report 90661 for Flucelvax through December 31, 2016. On or after January 1, 2017 report 90674. Do not report 90674 until that time."
 - o 90661 (2016) Influenza virus vaccine, derived from cell cultures, subunit, preservative and antibiotic free, for intramuscular use





Flu Vaccines

- Vaccine Modifications Ages were removed in favor of dose amounts (except for 90644) to encourage reference to individual product's prescribing information.
- 90655 Flu tri, split virus, preserv free 0.25 ml, IM
- 90656 Flu tri, split virus, preserv free 0.5 ml, IM
- 90658 Flu tri, split virus, 0.5 ml, IM
- 90661 Flu tri, from cell cultures, subunit, preservative- & antibiotic free, 0.5 ml, IM
- 90685 Flu quad, split virus, preservative free, 0.25 ml, IM
- 90686 Flu quad, split virus, preservative free, 0.5 ml, IM
- 90657 Flu tri, split virus, 0.25 ml, IM 90687 Flu quad, split virus, 0.25 ml,
 - 90688 Flu quad, split virus, 0.5 ml, IM





Vaccines

- More Modifications
 - o 90644 Meningococcal conjugate vaccine, serogroups C & Y and Haemophilus influenza type b vaccine (Hib-MenCY), 4 dose schedule, when administered to children 6 weeks-18 months of age, for intramuscular use
 - o 90734 Meningococcal conjugate vaccine, serogroups A, C, Y and W-135, quadrivalent (MCV4 or MenACWY), for intramuscular use





Psychotherapy

90832, 90833(+), 90834, 90836(+), 90837, 90838(+)

- Wording is now "w/patient"; deleted "and/or family member".
 Clarification based on for whom the therapy is intended, not who is in attendance.
- Examples added to reinforce the midpoint rule should guide code selection.
- Language change from "Family member" to "informant" in section guidance does not disqualify code use when informant is a family member. Simply broadened to include informants.





Psychotherapy

90846, 90847 - Family psychotherapy

 Time added (50" for each). Establishes that less than 26" should not be reported (midpoint rule)





Bill ALL Services

Ophthalmology code, 92140 (Provocative tests for glaucoma, with interpretation and report, without tonography) **deleted** citing maintenance of code set by *omitting low utilization procedures*.





2017 CPT Changes

Telehealth Additions:

- New symbol ★ = Telemedicine eligible code
- New place of service 02 = Telehealth
- Modifier 95 Synchronous Telemedicine Service Rendered via a Real-Time Interactive Audio and Video Telecommunications System
- Appendix P CPTs that may be used for synchronous Telemedicine





2017 CPT Changes

Additions:

- New section "Proprietary Laboratory Analyses"
 - o To be released quarterly
 - Updates at amaproductupdates.org
- New G codes, for now. CPTs in 2018?
 - o Behavioral Health Integration Codes
 - G0502, G0503, G0204, G0507
 - $\circ \quad \text{Comp assess and care planning for patients with cognitive impairment} \\$
 - G0505





2017 CPT Changes

Additions (cont'd):

- 36456 Partial exchange transfusion, MD, Newborn
- Admin health risk assess, scoring and documentation, per instrument (0.13 RVUs each; interpretation, assessment, planning are E&M)
- o 96160 patient focused
- o 96161 caregiver focused





2017 CPT Changes

Updates:

Geographic Practice Cost Index (GPCI) Adjustments

- Updated data
- CA locality structure





2017 CPT Changes

Deletions:

- 99420 Administration and interpretation of health risk assessment instrument (eg, health hazard appraisal)
- o Instead use 96160 and 96161 (no work RVU -Physician expense (scoring and documentation only; no interp or diagnosis effort).





CPT in the Future

- Psychiatric Collaborative Care Management
 Billed by PCP working with behavioral health manager and consulting psychiatrist. RUC's consideration of these new services was deferred by specialists'
- Info gathering re: zero day globals
 Advanced diagnostic imaging (New restrictions on placing) orders)
