"I need a diagnosis name and code for travel medication or Travel med education or medication eval or something like that, just so I can bill out a PCC visit but they all come up undetermined. What can I use?"





Coding Answer #1

Manually map the SNOMEDs for Travel abroad, etc to these ICDs for billing:

Z71.89 Other specified counseling Z23 Encounter for immunization



Coding Question #2

"No matter which SNOMED you choose for lump in breast, it only gives you N63. Do have a suggestion for a different SNOMED?"



Coding Answer #2

N63.0 Unspecified lump in unspecified breast N63.1 Unspecified lump in the right breast N63.10 ...unspecified quadrant N63.11 ...upper outer quadrant N63.12 ...upper inner quadrant N63.13 ...lower outer quadrant N63.14 ...lower inner quadrant



Coding Answer #2

N63.2 Unspecified lump in the left breast N63.20 ... unspecified quadrant N63.21 ... upper outer quadrant N63.22 ...upper inner quadrant N63.23 ...lower outer quadrant N63.24 ...lower inner quadrant

N63.3 Unspecified lump in axillary tail N63.31 Unspecified lump in axillary tail of the right breast

N63.32 Unspecified lump in axillary tail of the left breast

N63.4 Unspecified lump in breast, subareolar N63.41 Unspecified lump in right breast, subareolar N63.42 Unspecified lump in left breast, subareolar






