Procedure Table Edits

NEVER overwrite an entry in your procedure table!!!

Work with your CA to retire entries that you know you will no longer use or to add revised versions of updated codes.

2019 CPT Changes

REVISED:

- 99446 Interprofessional telephone/Internet/**electronic health record** assessment and management service provided by a consultative physician, **including a verbal and written** report to the patient's treating/requesting physician or other qualified healthcare professional , 5-10 minutes of medical consultative discussion and review
- 99447 ...11-20 minutes
- 99448 ...21-30
- 99449 ...31 or more



2019 CPT Changes

NEW:

99451 Interprofessional telephone/Internet/electronic health record assessment and management service provided by a consultative physician, **including a written report** to the patient's treating/requesting physician or other qualified healthcare professional, 5 minutes or more of medical consultative time



Interprofessional Telephone/Internet/Electronic Health Record Assessment and Management Service Comparison

Codes 99446, 99447, 99448, 99449 conclude with a verbal opinion report and written report from the consultant to the treating/requesting physician or other qualified healthcare professional. Code 99451 concludes with only a written report.

Review of pertinent medical records, laboratory studies, imaging studies, medication profile, pathology specimens, etc is included in the telephone/Internet/electronic health record consultation service and should not be reported separately when reporting 99446, 99447, 99448, 99449, 99451. The majority of the service time reported (greater than 50%) must be devoted to the medical consultative verbal or Internet discussion.

If greater than 50% of the time for the service is devoted to data review and/or analysis, 99446, 99447, 99448, 99449 should not be reported.

However, the service time for 99451 is based on total review and interprofessional-communication time.

99452 Interprofessional telephone/Internet/electronic health record referral service(s) provided by a treating/requesting physician or other qualified healthcare professional, 30 minutes

2019 CPT Changes

NEW:

90689 Influenza virus vaccine, quadrivalent (IIV4),
inactivated, adjuvanted, preservative free, 0.25mL dosage,
for intramuscular use



2019 CPT Changes

REVISED:

94780 Carseat/bed testing for airway integrity, *for infants
through 12 months of age*, with continual nursing clinical staff
observation and continuous recording of pulse oximetry,
heart rate and respiratory rate, with interpretation and
report 60 minute

94781...each additional 30 minutes



2019 CPT Changes

DELETED: 96111 Developmental testing, (includes assessment of motor, language, social, adaptive, and/or cognitive functioning by standardized developmental instruments) with interpretation and report



2019 CPT Changes

NEW (Replaces 96111):
96112 Developmental test administration (including assessment of fine and/or gross motor, language, cognitive level, social, memory and/or executive functions by standardized developmental instruments when performed), by physician or other qualified healthcare professional, with interpretation and report first hour
96113...each additional 30"



2019 CPT Changes

NEW:
99491 Chronic care management services, **provided personally by a physician or other qualified healthcare professional**, at least 30 minutes of physician or other qualified healthcare professional time, per calendar month



2019 CPT Changes

NEW:

97151 Behavior identification assessment, **administered by a physician or other qualified healthcare professional**, each 15 minutes of the physician's or other qualified healthcare professional's time face-to-face with patient and/or guardian(s)/caregiver(s) administering assessments and discussing findings and recommendations, and non-face-to-face analyzing past data, scoring/interpreting the assessment, and preparing the report/treatment plan



2019 CPT Changes

NEW:

97152 Behavior identification-supporting assessment, **administered by one technician** under the direction of a physician or other qualified healthcare professional, face-to-face with the patient, each 15 minutes

97153-97158 are for adaptive treatment



2019 CPT Changes

DELETED 99090 Analysis of clinical data stored in computer
Replaced by:

NEW 99453 Remote monitoring of physiologic parameter(s) (eg, weight, blood pressure, pulse oximetry, respiratory flow rate), initial set-up and patient education on use of equipment

99454 ... device(s) supply with daily recording(s) or programmed alert(s) transmission, each 30 days



New Patient

“Solely for the purposes of distinguishing between new and established patients, professional services are those face-to-face services rendered by physicians and other qualified healthcare professionals **who may report evaluation and management services** reported by a specific CPT code(s). A new patient is one who has not received any professional services from the physician/qualified healthcare professional or another physician/qualified healthcare professional of the exact same specialty and subspecialty who belongs to the same group practice, within the past three years.”
