But First#2 ...2020 Modified Modifiers!

50 Bilateral Procedure

Note: This modifier should not be appended to designated "add-on" codes (see Appendix D)"

63 - Procedure Performed on Infants less than 4 kg

Note: Unless otherwise designated, this modifier may only be appended to procedures/services listed in the 20100-69990 code series and 92920, 92928, 92953, 92960, 92986, 92987, 92990, 92997, 92998, 93312, 93313, 93314, 93315, 93316, 93317, 93318, 93452, 93505, 93530, 93531, 93532, 93533, 93561, 93562, 93563, 93564, 93568, 93580, 93582, 93590, 93591, 93592, 93615, 93616 from the Medicine/ Cardiovascular section. Modifier 63 should not be appended to any CPT codes listed in the Evaluation and Management Services, Anesthesia, Radiology, Pathology/Laboratory, or Medicine sections (other than those identified above from the Medicine/Cardiovascular section)

3 Clinicians on Call 15 visits x \$7.95 = \$119.25 x 6 = \$715.50

- 1 Clinician 25 visits x \$7.95 = \$198.75 x 4 = \$795
- 2 Clinicians 50 visits x \$7.95 = \$397.50 x 4 = \$1,590

- March v8.7:
 - Due Dates to Future Tasks
 - Generate and reprint batch forms
 - Practice Management window in PCC EHR improved
 - Portal Payments
 - Eliminate claim failures caused by duplicate posting of CARC amounts
- June v 8.9
 - New messaging templates in the Patient Portal
 - Portal Users can see the personal balance due all of their kids
 - Portal Payments automatically post payments which failed before
 - Multiple, simultaneous EHR windows with quick navigation
 - "Last 5 documents" view added
 - Pilot deployment of QBCDE Query Responder infrastructure
 - Reports now feature sub-totals
 - New Deposit report in PCC EHR
