COVID-19 Bivalent Booster Code Claim Rejections

- Claims reporting 91312 / 0124A (Pfizer >12y) or 91313 / 0134A (Moderna >18yr) are being rejected erroneously by clearinghouses and payors alike
 - Availity (various payors including Anthem, Centene, HCSC, Humana)
 - Value of sub-element SV101-02 is incorrect.
 - Change Healthcare (various payors including Aetna, Horizon, TRICARE)
 - REJECTED AT CLEARINGHOUSE LINE LEVEL PROCEDURE CODE IS MISSING OR INVALID
 - PNT Data (Cigna)
 - Value of sub-element SV101-02 is incorrect.

- 837 Professional Loop 2310B




- Prior to HIPAA 5010 (2012), it was common for payors to expect
 both the claim Billing and Rendering Providers to be individuals
- The HIPAA 5010 electronic claim standard (837 Professional) states the following with regard to the Billing Provider:

The Billing Provider may be an individual only when the health care provider performing services is an independent, unincorporated entity. In these cases, the Billing Provider is the individual whose social security number is used for 1099 purposes. That individual's NPI is reported in NM109, and the individual's Tax Identification Number must be reported in the REF segment of this loop. The individual's NPI must be reported when the individual provider is eligible for an NPI. See section 1.10.1 (Providers who are Not Eligible for Enumeration).

- Per HIPAA 5010, a practice's claim Billing Provider (Box 33 / Loop 2000A) is now generally that practice itself
 - This is considered distinct from the claim Service Facility (Box 32 / Loop 2310C) though the entities may be one and the same
- The practice's claim **Rendering Provider** (Box 24J / Loop 2310B) is thus the only individual provider generally reported
- Both the NUCC 1500 Form and 837 Professional allow for reporting of a claim **Supervising Provider** (Box 17 / Loop 2310D) but this is not widely supported
