# Bivalent COVID-19 Vaccine Administration

**Addition of More Bivalent COVID-19 Administration Codes:** In late April, the FDA removed EUA for monovalent COVID-19 vaccines and expanded authorization for bivalent vaccines. This resulted in new administration billing codes (0171A, 0172A, 0151A, 0121A, 0141A, 0142A). These codes are retroactively available to April 18th, 2023. PCC updated your practice's claim validation lists for the new codes.
