## PCC Change Healthcare EDI Update

#### PCC has significantly reduced Change Healthcare EDI dependency

• PCC retains a robust and growing EDI transaction routing network

- PCC leverages a complementary combination of direct-to-payor and clearinghouse
  EDI to provide the most direct, cost-effective, and well-supported eligibility verification, claim, claim response, and electronic remittance advice processing
- PCC routes only 2% electronic claims through Change Healthcare Revenue Performance Advisor (formerly ProxyMed / MedAvant / Capario)
  - Change Healthcare did not restore the former Emdeon EDI gateway
- PCC continues to utilize the Optum iEDI clearinghouse for UnitedHealthcare and affiliate EDI as the most direct-to-payor option

#### **TRICARE West Changes Effective January, 2025**

#### <u>Know How TRICARE Regions Are Changing in 2025</u>


- Six states currently in the East Region (Arkansas, Illinois, Louisiana, Oklahoma, Texas, Wisconsin) will move to the West Region.
- The TRICARE West region contractor will switch from Health Net Federal Services to TriWest Healthcare Alliance on Jan. 1, 2025
- Some features won't be available on the TriWest website until Nov. 2, 2024.

#### **TRICARE West Changes Effective January, 2025**

- <u>TRICARE West Region Contract Transition: Frequently Asked</u>
  <u>Questions</u>
  - Will my network contract with HNFS automatically transfer to TriWest?
    - No. Providers will need to contact TriWest about joining TriWest's West Region network.
  - Will beneficiaries have to re-enroll for their benefits?
    - No. TRICARE beneficiaries who are currently eligible for and enrolled in a TRICARE plan should experience no interruption in TRICARE coverage. DHA encourages beneficiaries to check <u>DEERS</u> to confirm all their information is current.
- PCC is researching and will advise on EDI provider enrollment process for electronic claim submission and receipt of electronic remittance advice via PCC's Availity interface (payor ID 99726) as applicable
