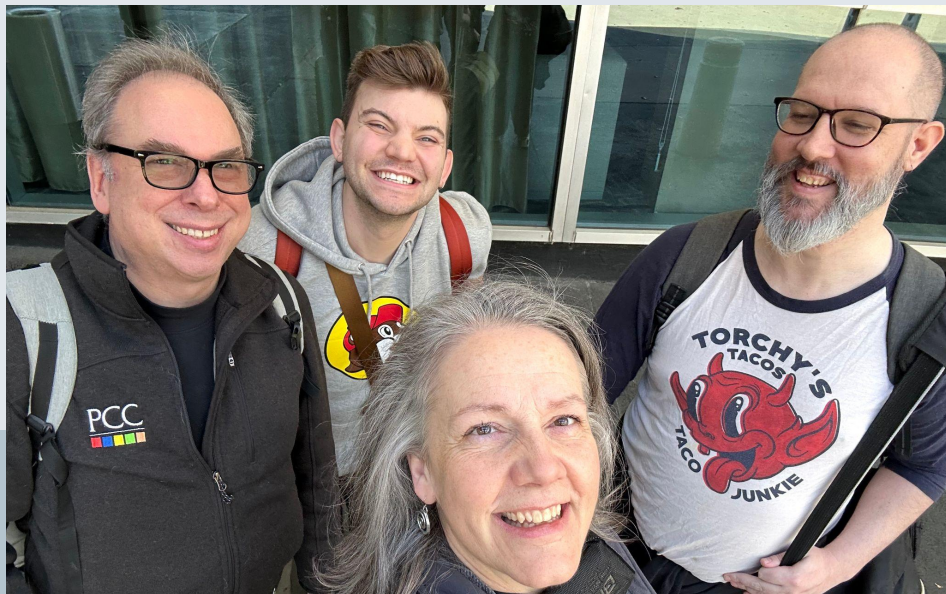

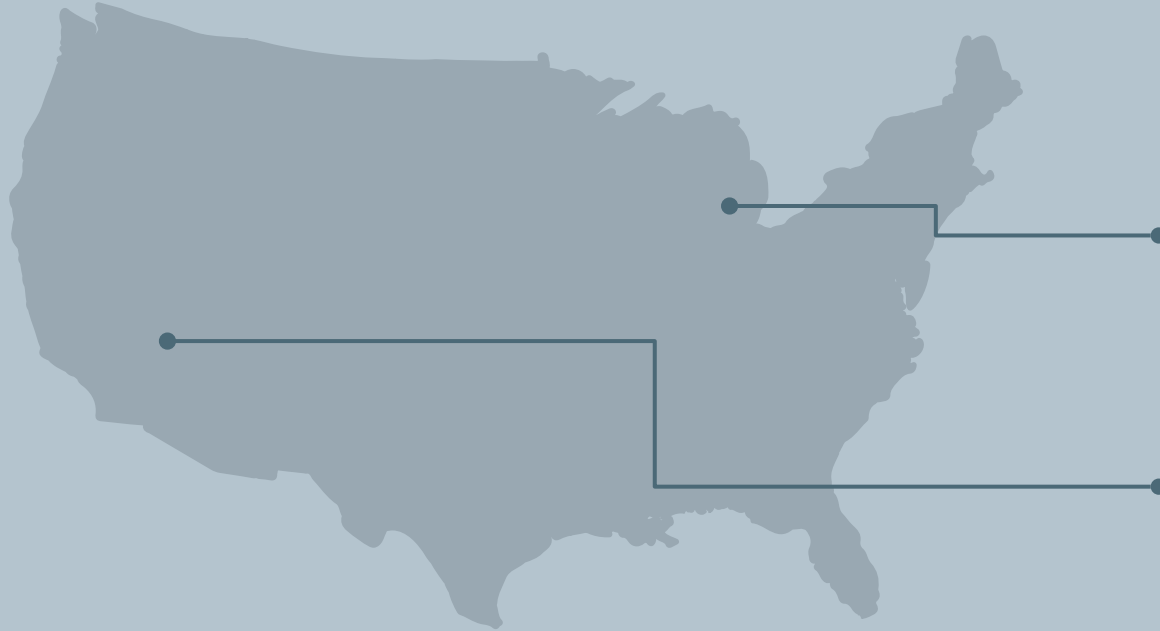

TRICARE EAST AND WEST 2025



TRICARE WEST 2025

- Contractor: TriWest Healthcare Alliance (NEW)
- EDI Claims Processor: PGBA



TRICARE EAST 2025

- Contractor: Humana Military
- EDI / Claims Processor: PGBA (NEW)
- Six states currently in the East Region (Arkansas, Illinois, Louisiana, Oklahoma, Texas, Wisconsin) will move to the West Region.

TRICARE EAST 2025

- Beginning 1/1/2025:
 - Claims for service dates in 2024 must be submitted through WPS
 - Claims for service dates in 2025 must be submitted through PGBA using new payor ID 99727
- Your PCC system is configured to route electronic claims accordingly through WPS (current payor ID TREST) and Availity (new payor ID 99727)



TRICARE EAST 2025

To submit claims for 2025 service dates you need to:

- Create a new TRICARE East Insurance Companies table (ted) entry
 - Clone existing TRICARE East entry to start
 - Assign new claim mailing address
 - Assign Payor ID 99727
 - Assign policy to TRICARE East patients for 2025 service dates



TRICARE WEST 2025



If you are in one of the six states moving from the East Region to the West Region (Arkansas, Illinois, Louisiana, Oklahoma, Texas, Wisconsin) and will submit claims for 2025 service dates :

- Create a new TRICARE West Insurance Companies table (ted) entry
- Clone your existing TRICARE East entry to start
- Assign new TRICARE West claim mailing address
- Assign Payor ID 99726
- Assign policy to TRICARE West patients for 2025 service dates

TRICARE EAST AND WEST 2025



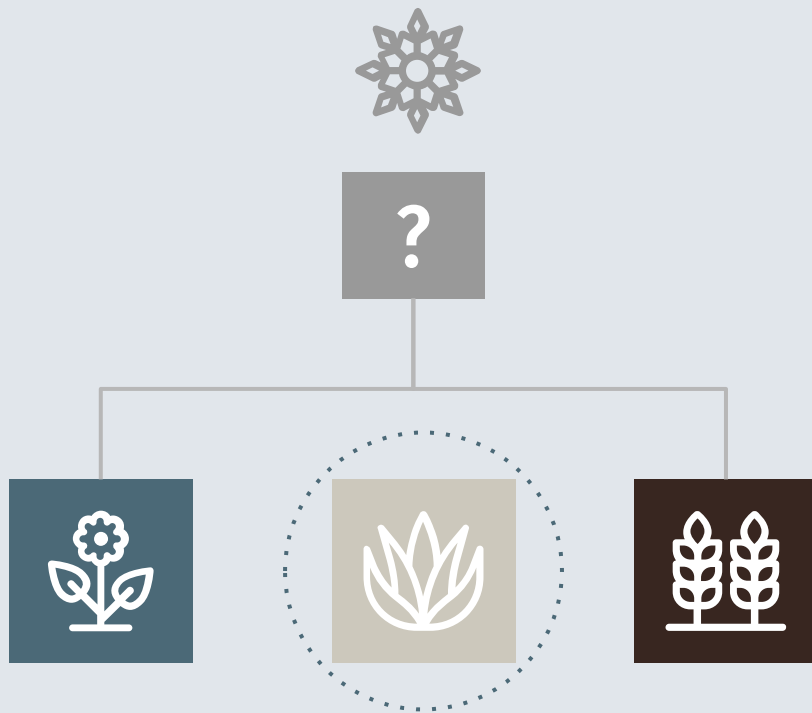
- **PCC awaits provider EDI (electronic claims, electronic remittance advice) enrollment guidance from Availity and PGBA**
- **Change Healthcare has suggested that no provider EDI enrollment will be necessary for TRICARE East electronic claim submission to PGBA in 2025 (PCC is verifying)**
- **Provider EDI reenrollment for electronic remittance advice will likely be required for both TRICARE East and TRICARE West in 2025**
