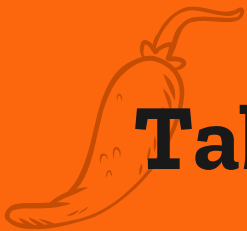

2025 TRICARE Changes Update

TRICARE EAST Electronic Claim Submission (ECS)

- **PCC has:**
 - Configured your TRICARE East electronic claims to route through PCC's Availity clearinghouse interface to PGBA via new payor ID **99727**
- **You should:**
 - Clone your 2024 TRICARE East Insurance Companies table entry in your PCC system
 - Assign this new entry Payor ID **99727**
 - Assign the policy to TRICARE East patients you treat on 2025 service dates



2025 TRICARE Changes Update

TRICARE EAST Electronic Remittance Advice (ERA)

- **You should:**
 - Email your completed Humana Military / PGBA Electronic Remittance Advice (ERA) enrollment form to PCC Support (support@pcc.com)
 - Consult directly with Humana Military / PGBA regarding Electronic Funds Transfer (EFT)
- **PCC will:**
 - Coordinate processing of your completed enrollment form with Availity and PGBA accordingly



2025 TRICARE Changes Update

TRICARE West Electronic Claim Submission (ECS)

- For PCC practices located in the six states moving from the TRICARE East to the TRICARE West Region (**AR, IL, LA, OK, TX, and WI**):
 - **PCC has:**
 - Initiated your TriWest / PGBA / Availity provider enrollment
 - Configured your TRICARE West electronic claims as directed to the existing payor ID **99726** to route through PCC's Availity clearinghouse interface to PGBA



2025 TRICARE Changes Update

TRICARE West Electronic Claim Submission (ECS)

- For PCC practices located in the six states moving from the TRICARE East to the TRICARE West Region (**AR, IL, LA, OK, TX, and WI**):
 - **You should:**
 - Clone your current TRICARE East Insurance Companies table entry in your PCC system
 - Rename the cloned entry to reflect TRICARE West
 - Assign this new entry Payor ID **99726**
 - Assign the policy to TRICARE West patients you treat on 2025 service dates
 - Contact PCC Support (support@pcc.com) if you have not received and returned your TriWest / PGBA / Availity provider enrollment

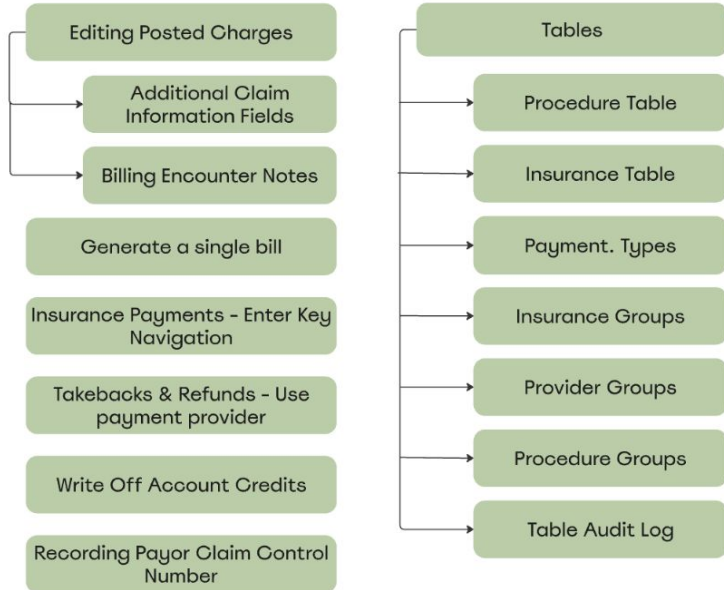

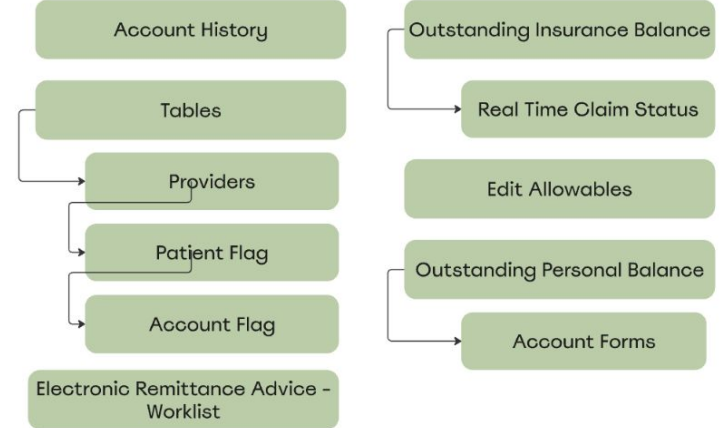
