*Resend:
Only when you want to!*

- Resend button will automatically display for ALL prescriptions
- Does not indicate there was an issue with a recent prescription
- Use Resend to:
 - A) edit prescription and send back to original pharmacy
 - B) switch to a different pharmacy
- Will automatically delete original rx > send cancellation to the pharmacy > display history in Review & Sign
- Subsequent Rx will also show option to Resend
- Only available for 7 days!

Automatically prescribe logical package sizes for liquids and drops

Updated in 9.8:

- Uses minimum commercial package size for dispense qty
 - Eye/ear drops
 - Reconstituted ABX
- Uses # of mL for larger bulk bottles (ex: Bactrim)
- Provides best RTPB results

Planned Improvements Identified from 9.8 Feedback



❖ Future

- ❁ Include pending options so non-providers can utilize the resend functionality
- ❁ Add extra flexibility for resending individual months within a 3 month supply
- ❁ Future: Allow users to resend from other locations in PCC eRx

eRx Specific Patch planned for January 2024



- ❁ Fixes for asynchronous errors relating to:
 - Creating a prescription from the blue pad with pencil icon
 - Adding or editing certain entries in Medication History
 - Prescribing drugs like Mounjaro or Synagis
- ❁ Display issue: previous provider carried forward on renewals visible on RapidRx screen (*correct provider is sent to pharmacy*)
- ❁ eRx Message Queue issues - resulting in stuck or not-yet-sent prescriptions
- ❁ Other production fixes
 - Say goodbye to the blue login screen!
 - Favorites: 3 month supply & DAW status will now properly display
 - Removed access for Non-Clinical staff to be able to renew prescriptions w/ blue swish
 - DEA number now correctly displays on printed prescriptions
