Important Improvements & Bug Fixes - PCC eRx



- ❖ View accurate and up-to-date prescription benefits while you prescribe (RTPB & ODF)
- ❖ See when an item in Medication History has an active prescription
- ❖ Specify which prescriptions to send a cancel message for
- ❖ Reroute prescriptions to a different pharmacy with one click
- ❖ Prescribe controlled substances without running into unexpected future stop date or days supply limit errors
- ❖ Improved logic and display when you delete a prescription or discontinue a medication
- ❖ Edits to historic medications carry over when you renew with the blue swish
- ❖ Improved logic to decide when a unique row gets created in Medication History in PCC eRx

Important Improvements & Bug Fixes - PCC eRx



- ❖ Better handling of stop dates and auto-expiration in PCC eRx and PCC EHR
- ❖ Fewer opportunities for Start Date errors on new prescriptions
- ❖ One-time only prescriptions automatically become inactive after one day in Medication History
- ❖ Identify 3-month supply prescriptions at-a-glance in Medication History with a "3 month supply" label
- ❖ Clearer view into prescribing activity on an eRx encounter with improved Reconciliation History
- ❖ Receive safety alerts only for *active* diagnoses and medications
- ❖ See patient instructions when viewing prescriptions linked to a historic medication

Important Improvements & Bug Fixes - PCC eRx



- ❖ Automatically prescribe the minimum commercial package size for liquids and drops
- ❖ Utilize smarter dispense quantity logic on prescriptions that reference "both" eyes, ears, or nostrils
- ❖ Reduce disruption to prescribing from historic entries or favorites if medication moves to off-market status
- ❖ Transmit more appropriate NDC's for brand and generic prescriptions
- ❖ Say goodbye to issues with Albuterol HFA inhalers
- ❖ Use the Patient Takes No Medications option error-free
- ❖ Create custom search terms for your preferred nebulizers, medications, and more
