Real world responses from the registry

- **NK1**: Responsible person required in the NCIR. No NK1 segment provided.
- **RXA**-17 (SubstanceManufacturerName): Has a conditionally required element [SubstanceManufacturerName]. Expectation: value is not empty (or set to UNK) when the first occurrence of RXA-9.1 is valued "00" and RXA-20 (CompletionStatus) is valued "CP" or "PA".
- If RXA-20 is valued "CP" or "PA" and the first occurrence of RXA-9.1 (Administration Note code) is valued "00" then the message SHALL include an OBX segment associated with the RXA with **OBX**-3.1 shall equal "64994-7" indicating Funding Eligibility.

What the H*^~! are all these 3 letter words?

HL7 (Health Level 7) is a messaging format used to communicate clinical data electronically. Sometimes registries will return responses that refer to various segments of the message they receive.





Basic HL7 reference

PID and NK1: Demographics

RXA and RXR: The immunization

OBX: Additional details

Demographics

PID - Patient Identification:

- Patient's Name, DOB, Sex, Race, Ethnicity
- Patient's custodial account's Address, Phone, Email

PD1 - Patient Additional Demographics:

• Share with registry, Preferred Contact Method for the Immunization Registry, Patient's Immunization Registry Status

NK1 - Next of Kin / Associated Parties:


• Comes from Personal Contacts listed on the patient




Immunization Order Lot number links Manufacturer, NDC, Funding Source and Expiration Date in the vaccine lot manager


- Invalid character in name
